DIRECTIONS

From South off I-35

Head North on Interstate 35 and exit Riverside Dr. Turn Left on Riverside Dr. Stay on Riverside Dr. for approximately 1 mile cross Congress Ave and turn left on Barton Springs Rd. Follow Barton Springs Rd down to the entrance of Zilker Park. Entrance and Parking will be on the right.

From North off I-35

Head South on Interstate 35 and exit Riverside Dr. Turn Right on Riverside Dr. Stay on Riverside Dr. for approximately 1 mile cross Congress Ave and turn left on Barton Springs Rd. Follow Barton Springs Rd down to the entrance of Zilker Park. Entrance and Parking will be on the right.

From North off Mopac Expressway (Loop 1)

Head South on Mopac Expressway (Loop 1) and exit Bee Caves Rd (FM 2244) loop back under Mopac and follow the access road around as it turns into Barton Springs Rd. Follow Barton Springs Rd down to the Zilker Park entrance. Entrance and Parking will be on the left side of Barton Springs Rd.
